This application can be used to request access to the online facilities on behalf of a patient. You can only do this if you are the parent, legal guardian or registered carer of the patient.

The applicant must be aged 16 years or older and for security reasons you will need to provide photo evidence of your identity such as a passport or photo driving licence. The patient you are applying for will also be required to supply proof of identity where possible.

Each case will be examined on an individual basis.
